- 3. Principal is obliged to immediately notify the agent and the competent customs administrations about authorization withdrawal. Otherwise authorized will continue to act on behalf of the Principal.
- 4. Submitting this authorization Principal is obligated to pay stamp duty. **
- 5. Principal of this authorization further declares that he takes responsibility:
 - a. for the accurate translation of invoices into Polish,
 - b. for the actual compliance of the product with the documents as to the quantity, weight, type and value,
 - c. for the deadlines laid down in the course of the proceedings.
- 6. SKY-MAR Marek Zaworski can secure the customs duties and tax charge, secured payments should be made to SKY-MAR Marek Zaworski account on the basis of written e-mail information. Principal authorizes SKY-MAR Marek Zaworski to issue VAT invoices without the recipient's signature.
- 7. The authorization (original) must be accompanied by copies of Principal constituent documents:
 - a. a. copy / information corresponding to the current write-off from the Register of the National Court Register or certificate of registration / printout from the Central Registration and Information on Business,
 - b. certificate of assigning statistical number,
 - c. attestation of assigning tax number,
 - d. attestation of having a bank account.
